This memorandum of an agreement made between The Trustees of the Oconee Hill Cemetery, a corporation of said State and County, of the one part, hereinafter referred to as "The Trustees", and G. C. Meadowcroft, of Augusta, Georgia, of the other part, hereinafter referred to as "the owner", Witnesseth:

--1--

This agreement is made under the authority conferred upon The Trustees in the charter of the Company, and the several amendments thereto.

--2--

The owner has paid to the Trustees the sum of ONE HUNDRED AND FIFTY (\$150.00) DOLLARS, which is to be held and administered upon the trusts hereinafter referred to.

--3--

The principal of the fund referred to shall be invested in the manner provided by the existing rules of the Trustees, or such rules as may hereafter be adopted by the Trustees.

--4--

The annual interest or income from such principal shall be used by the Trustees in the care, preservation and ornamentation of the following lot in Oconee Hill Cemetery, to-wit: the Meadowcroft lot, No. 160, C West Hill, Survey by Charles M. Strahan, 1894.

--5--

Returns shall be made by the Trustees to the Ordinary, as provided in the Charter and Rules of the Company.

--8--

In Witness whereof the Trustees have caused this agreement to be executed in duplicate and to be signed in the corporate name by the President, and its corporate seal to be hereto affixed, and the owner has hereunto set his hand and seal, this 6 day of July 1918.
